**OPENING COMMENTS**

The purpose of this visit is a reinspection at the request of the facility to verify the conditions causing the health permit suspension have been corrected.

On this date, a pest control receipt from Dewey Pest Control was provided indicating service after the routine inspection. A thorough inspection of the facility was conducted. No further evidence of cockroach activity was observed.

- All of the violations occurring inside the facility noted on the routine inspection were observed corrected. The shared dumpster in the back alley was still uncovered. (See FM 44).

The health permit was reinstated on this date.

A follow-up is scheduled for February 21, 2019 to verify the continued abatement of the cockroach activity.

**42. GARBAGE AND REFUSE PROPERLY DISPOSED; FACILITIES MAINTAINED - OUT OF COMPLIANCE**

Inspector Comments: Observed the trash dumpster lids at the back alley to be propped open. Maintain the trash lids closed at all times except when in use to prevent insect and rodent development, including odors.

Violation Description: All food waste and rubbish shall be kept in leak-proof and rodent-proof containers. Containers shall be covered at all times. All waste must be removed and disposed of as frequently as necessary to prevent a nuisance. The exterior premises of each food facility shall be kept clean and free of litter and rubbish.
