This reinspection was conducted at the request of the operator. Currently, there are no apparent signs of rodents, and all identified rodent entry points (front and delivery doors, wall holes, etc.) have been adequately addressed.

Issues still requiring further/ongoing attention included the cleaning of floors throughout the facility and ensuring that (with the exception of whole boxes of product) everything is stored up off of the floor on approved storage structures (e.g., discontinue using unapproved storage crates).

A reinspection will occur on 5/13/19 to ensure the continued abatement of vermin and to verify that the cleaning and storage issues noted above have been corrected.

This facility's permit has been reinstated.
