The purpose of this visit is a follow-up inspection at the request of the facility to verify the conditions causing the closure have been abated.

On this date, a pest control receipt from Griffin Pest Control was provided indicating service in the morning prior to this inspection. The areas noted for activity and the surrounding areas were inspected. Various gaps and holes were observed sealed. The areas noted for activity were observed to be cleaned. No further evidence of cockroach activity was observed.

Various violations noted on the inspection report were observed to be corrected.

The health permit was reinstated on this date.

A 2nd reinspection is tentatively scheduled for May 7, 2019 to verify the continued abatement of the cockroach activity.
