#### OPENING COMMENTS

This reinspection was at the request of R. Sarai, Owner, in response to the permit suspension on 1/21/20 for rodent activity in critical areas. During this inspection it was observed that all signs of rodent activity had been removed and the hole under the oven had been covered. A few spots were pointed out to the owner which still needed deeper cleaning and it was mentioned by the owner that they would pressure wash the floor prior to the 1-week reinspection date. A reinspection has been scheduled for 1/29/20 to verify that rodent activity was successfully eliminated.
