OPENING COMMENTS

This recheck was at the request of the PIC, A. DeLeon after permits suspension on 11-14-19 for evidence of rodent activity. This date no evidence of activity was observed. Potential entry points noted on the report were sealed; all areas of the facility were cleaned/organized and preventative glue traps were set up throughout.

A 1-week follow up inspection is scheduled to verify that all activity was effectively eliminated. Maintain exterior doors and any windows without screens closed and regularly inspect all screens and weatherstrips under doors to make sure they are in good repair.

The health permit is herewith reinstated.
