OPENING COMMENTS

This recheck was at the request of the owner J. Hwang after permit suspension for rodent infestation on 3-27-19. At this time no evidence of activity was observed and all violations noted on the 3-27-19 report were corrected. All unapproved bait traps were replaced with approved glue traps. The health permit is herewith reinstated. A 1-week follow up inspection is scheduled to verify that rodent activity is effectively and permanently eliminated.
