OPENING COMMENTS

The purpose of this visit is a follow-up inspection at the request of the facility to verify the abatement of the cockroach activity.

On this date, a pest control receipt from Orkin was provided indicating service on 3/27/2019. The areas noted for activity and the surrounding areas were inspected. No further evidence of live cockroach activity was observed.

- The unused walk-in freezer was observed to operable and the ambient air was measured at 41F.

The health permit is reinstated on this date.

A 2nd reinspection is tentatively scheduled for April 18, 2019 to verify the continued abatement of the cockroach activity.
