OPENING COMMENTS

This report supersedes the hand-written report left on-site.

Inspector Comments: This was an after-hours reinspection at the request of the facility operator, to determine if the health permit could be reinstated after suspension for cockroach infestation.

The health permit was reinstated this date. No evidence of cockroach infestation was observed. A thorough inspection of all areas noted on the inspection report dated 9-20-2019 was conducted.

Areas were visibly clean, per the facility operator, all areas had been cleaned and sanitized. A receipt for pest control service performed the day before, 9-20-2019, was available, indicating a fogging treatment had been performed.

The Reinspection Pass seal was posted. A recheck for cockroach activity will be performed on or after 10-14-2019 to ensure no further evidence of cockroach activity is found.
