During this visit, the person in charge presented a pest control receipt dated on 3/20/19 and no live activity was observed.

2 dead cockroaches were observed on the floor of the right side of the 3 compartment sink.

Corrective action taken: The second person in charge immediately removed the evidence of activity, cleaned and sanitized the area.

Continue to bring the remaining violations from the routine and reinspection report to compliance and maintain the facility in a clean manner.
