**OPENING COMMENTS**

The purpose of this 3rd follow-up visit was at the request of C. Badgwell regarding a cockroach infestation that resulted in a health permit suspension on December 21, 2018. At the time of inspection, no evidence of cockroach infestation was observed. All areas were observed to be cleaned and gaps/crevices/holes were observed to be sealed. This facility stated that they have an active pest control management plan. The health permit was reinstated and this facility may prepare and sell food.

A reinspection has been tentatively scheduled for January 22, 2019, to verify the continued abatement of cockroaches.
