**OPENING COMMENTS**

This is a follow-up visit at the request of the facility to reinstate the health permit due to a rodent infestation.

At the time of the inspection, observed rodent dropping on the floor below the shelving rack behind the front upright 3-door cooler. The manager stated that they forgot to clean that area; The area was immediately cleaned and sanitized. A thorough inspection was conducted for rodent activity. No further evidence observed.

A reinspection was tentatively scheduled for September 17th, 2018 to verify continued abatement of any rodent activity and the removal of the prep sink outside in the back area.
