#### **OPENING COMMENTS**

The purpose of this visit is a reinspection at the request of the facility. This was a joint inspection with E.Pang, EHS. On this date, hot water of at least 120F was measured at the facility. The facility provided a new water heater of 38,000 BTU. Violations noted on the previous report were corrected except for the Food Managers Certificate. See FM02.

The permit is hereby reinstated on this date.

A second re-inspection has been scheduled on February 19,2019, to verify a valid Food Managers Certificate.

#### 2. FOOD MANAGER CERTIFICATION; FOOD HANDLER CARDS - MINOR

Inspector Comments: Food Safety Certificate was not available at time of inspection. Provide Food Safety Certificate within 14 days. A reinspection is scheduled for February 19, 2019.

Violation Description: There shall be a Food Manager Certificate on the premises for the designated employee that has passed an approved and accredited exam. Food facilities that prepare, handle, or serve non-prepackaged food, shall ensure that all food handlers have an approved food handler card. (113947.1-113947.5, 113948)
