On this date, the following corrective actions were verified:

- 1) All cockroach evidence was eliminated from the affected areas.
- 2) Approved method of pest control and an invoice detailing the measures were provided.
- 3) All affected utensils and surfaces were cleaned and sanitized.
- 4) Gaps and/or crevices (noted on the 2/7/2019 report) were sealed.

The conditions causing the permit suspension were observed to be corrected. Your permit to operate is hereby reinstated.
