OPENING COMMENTS

PERMIT REINSTATEMENT

This inspection is at the request of C. Ngo in response to a permit suspension on 4/11/19 for rodent activity. See violation noted below. At this time all evidence of activity was eliminated and potential entry sites/gaps were sealed. The owner stated that all affected surfaces had been sanitized and several glue traps/snap traps were observed throughout the facility as a preventative pest control. Continue with approved pest control and regularly monitor all areas of the facility for vermin activity. The conditions causing the permit suspension were observed to be corrected. Your permit to operate is hereby reinstated. A 1-week reinspection has been scheduled for 4/18/19 to verify that vermin activity was effectively eliminated. Repeat activity on future inspections may result in further action from this agency.

24. NO RODENTS, INSECTS, BIRDS, OR ANIMALS - OUT OF COMPLIANCE

Inspector Comments: Observed a few rodent droppings underneath the water heater. The droppings were immediately removed by an employee and the affected area was cleaned and sanitized.

Violation Description: Each food facility shall be kept free of insects, birds, animals, or vermin: rodents (rats, mice), cockroaches, flies. (114259, 114259.1, 114259.4, 114259.5)
