- All affected areas were cleaned and sanitized.
- The meat slicer was removed from the facility as it is no longer used.
  - The small office cabinet was removed from the facility.
- All rodent activity has been eliminated on this date.

Your permit to operate is hereby reinstated.

A follow up inspection will be conducted on 6/19/2018 to verify that the facility remains in compliance.  
 A Notice of Violation (NOV) will be forthcoming.
