This inspection is at the request of L. Ha, Owner, in response to a permit suspension on 4/2/19 for cockroach activity. No evidence of cockroach activity was observed anywhere in the facility, and entry/harborage points were observed sealed.

All additional violations noted on the 4-2-19 routine inspection report were observed corrected. The conditions causing the permit suspension were observed to be corrected. Your permit to operate is hereby reinstated.

Continue with approved pest control methods and monitor all areas of the facility. A 3-week reinspection is scheduled to verify that cockroach activity was effectively eliminated.
