OPENING COMMENTS

This visit was at the request of I. Davalos, Owner, in response to the facilities permit suspension for cockroach activity. See violations noted below. Your permit is hereby reinstated. A 3-week reinspection has been scheduled to verify that cockroach activity was successfully eliminated.

24. NO RODENTS, INSECTS, BIRDS, OR ANIMALS - MAJOR

Inspector Comments: 1a. A few live cockroaches which showed symptoms of being poisoned were observed underneath the lip of one of the tables adjacent to the dish washer.

1b. A dead cockroach was observed on top of an electrical box behind a table in the back bar area.

The cockroaches were immediately eliminated/removed by the person in charge and the affected areas were cleaned and sanitized.

A thorough inspection for vermin activity was conducted. No further evidence was observed.

The owner provided several pest control receipts indicating several services since the last recheck.

2. A few dust covered rodent droppings were observed in the upstairs area of non-food/miscellaneous items.

The person in charge was instructed to remove and clean/sanitize the affected areas.

Violation Description: Each food facility shall be kept free of insects, birds, animals, or vermin: rodents (rats, mice), cockroaches, flies. (114259, 114259.1, 114259.4, 114259.5)

44. PREMISES: PERSONAL/CLEANING ITEMS; VERMIN-PROOFING - OUT OF COMPLIANCE

Inspector Comments: Observed a gap in the basecoving underneath the handwash sink in the back bar area.

Observed a gap in the basecoving/loose wall panels in the warewashing area.

These items were immediately sealed by an employee during the inspection.

Violation Description: The premises of each food facility shall be kept clean and free of litter and rubbish; non-food items shall be stored and displayed separate from food and food-contact surfaces; the facility shall be kept vermin proof; open-air barbecues shall be operated in an approved manner.
