**OPENING COMMENTS**

The purpose of this visit was in response to a permit suspension dated 02/19/19 for evidence of vermin activity.

A thorough inspection for vermin activity was conducted. No further evidence was observed.

2. Stored dishware was observed to be clean and free of debris.
3. Kitchen throughout and food contact surfaces were observed to be washed, rinsed and sanitized to eliminate vermin evidence. The locations listed in the routine inspection report were observed to be free of vermin evidence. Pest control was administered by staff and proven to be effective.
4. Blade of mounted can opener was observed to be clean.
