The purpose of this visit is at the request of Masaya, manager, to conduct a reinspection of a facility that was closed on 9/4/18 due to a cockroach infestation. Reinspections were conducted on 9/6/ and earlier on 9/7 2018 and cockroach activity was still observed. See previous inspection reports for details.

A thorough inspection for vermin was conducted and no further cockroach activity was observed. Continue to maintain the facility free of vermin and maintain it in a clean and sanitary manner.

Future issues with vermin will result in a Notice of Violation and/or an office hearing to be conducted.

The conditions causing the permit suspension were observed corrected and your health permit is hereby reinstated.

A Reinspection Due Pass Seal was posted on this date to verify that the facility remains free of vermin.
